This being the date and hour to which the Tuscaloosa County Commission adjourned, the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to approve the minutes of September 4, 2019.

Commissioner Jerry Tingle moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to acknowledge supernumerary retirement status for retiring Tax Assessor Doster McMullen at the maximum rate of compensation allowed by law.

Commissioner Stan Acker moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to authorize the Engineering Department to establish and post a 25 mph speed limit on Spain Drive, District I.

Planning Director Farrington Snipes presented the Commission details regarding the Holt Sanitary Sewer Extension Project. After discussion, Commissioner Jerry Tingle's motion to approve the project was seconded by Commissioner Reginald Murray. The motion failed on a three-to-two vote with Commissioner Stan Acker and Commissioner Mark C. Nelson casting the NAY votes.

Commissioner Reginald Murray moved, seconded by Commissioner Jerry Tingle, the County Commission voted unanimously to approve the revised construction agreement, Transportation Alternatives Program Project number: TAPAAF-TA15(942), between the Commission and the State of Alabama for the US Highway 11 Sidewalk Project.
