This being the date and hour to which the Tuscaloosa County Commission adjourned; the County Commission met pursuant to such adjournment with Probate Judge Rob Robertson presiding as Chairman. The following members were present:

Commissioner Mark C. Nelson moved, seconded by Commissioner Stan Acker, the County Commission voted unanimously to approve the minutes of June 26, 2024.

Commissioner Jerry Tingle moved, seconded by Commissioner Mark C. Nelson, the County Commission voted unanimously to go into executive session prior to the end of this meeting to discuss contract negotiations, board appointments, and potential litigation.

Commissioner Mark C. Nelson moved, seconded by Commissioner Reginald Murray, the County Commission voted unanimously to adopt a resolution approving and accepting the preliminary plat submission for Fox Lake Farms Phase Two, District III.

Commissioner Reginald Murray's motion to appoint Ms. Diane
Junkins to the Buhl, Elrod, Holman Water Authority to fill the vacancy
created by the passing of long-time member Eddie Ellis failed for lack
of a second.

Commissioner Stan Acker's motion to appoint Ms. Lesley Ellis Campbell to the Buhl, Elrod, Holman Water Authority was seconded by Commissioner Mark C. Nelson. Commissioner Reginald Murray offered an amendment to the motion that Ms. Diane Junkins be allowed to serve at the expiration of term (March 1, 2025). Commissioner Stan Acker declined the amendment. The motion to appoint Ms. Campbell passed 3-1 with Commissioner Reginald Murray casting the "NAY" vote.

There being no further business to come before the Tuscaloosa County Commission, the meeting adjourned to Wednesday, July 24, 2024.
